1 Mark welcomed the PCC and spoke about the busyness he was currently experiencing, which he also witnessed in the lives many of the church members, and of the full programme in the coming season ahead of the church with fundraising for Give-To-Go-Green and the NACRE Project. He said that for him Psalm 46 had meant a lot with the words "Be still and know that I am God" and he read the Psalm to us.

Psalms 46:1-11 (RSV) God is our refuge and strength, a very present help in trouble. Therefore we will not fear though the earth should change, though the mountains shake in the heart of the sea; though its waters roar and foam, though the mountains tremble with its tumult. There is a river whose streams make glad the city of God, the holy habitation of the Most High. God is in the midst of her, she shall not be moved; God will help her right early. The nations rage, the kingdoms totter; he utters his voice, the earth melts. The LORD of hosts is with us; the God of Jacob is our refuge. Come, behold the works of the LORD, how he has wrought desolations in the earth. He makes wars cease to the end of the earth; he breaks the bow, and shatters the spear, he burns the chariots with fire! "Be still, and know that I am God. I am exalted among the nations, I am exalted in the earth!" The LORD of hosts is with us; the God of Jacob is our refuge.

Mark then prayed that we would know the God of Jacob to be our refuge.

5 Written and Verbal Reports

5.1 Churchwardens Report

A previously circulated report from Fiona Rimmer was noted. The seriousness of the current repeat water leak was highlighted. Someone to find the leak has been contacted but is not able to come until early October.

5.2 NACRE project

- a) Quick Wins Grant Richard Bonnie has applied for this for the Roof Repair
- b) **Give to Go Green** begins on Friday with a variety of activities. Approximately £27,000 is needed for these works. The Diocese will match up to £10,000 raised. Sue Doggett has spoken to Mark about praying as a Church, but the current monthly Church Prayer meeting is poorly attended. Mac suggested praying after a service in the Sanctuary. No decision was made.
 - c) Fundraising for Work Packages. Nothing further to report

5.3 Finance Report. A printed copy of the current Financial Position was circulated. The current deficit is £2,766 and the 2024 deficit forecast as of 31/08 is £7,241 This is less than previously thought

Give to Go Green donations can be Gift Aided but the Gift Aid will not form part of the Give to Go Green total.

Two legacies have been given amounting to around £4k

a) Partners in Mission. A list had been previously circulated. It was agreed to support 4 missions and review in a year.

It was suggested that charities with a larger income would benefit proportionally less from the small amount we can offer (10% of our planned giving) so from the eight suggested, the ones chosen were

Hospiscare (local); The06 (our Mission Community); Mercy Ships (International); UCCF (local: SW Staff Worker).

5.4 Safeguarding Report and Action Plan

These had been previously circulated.

Sue Ritchie reported that a lot had changed in the few days since these went out. The Dashboard has been updated and now makes her job much easier. Currently our "score" is 98% but in going through the 12 areas regarding following guidance in roles that involve substantial contact with children, young people or vulnerable adults the meeting agreed all were being followed. This should bring our "score" back to 100%.

6.1 **Evangelism and Christianity Explored**. A positive report from Ann Turner was noted, following the start of the Christianity Explored course on Sept 9th. She said that the team were grateful for and conscious of the strong prayer support of many people in the congregation.

6.2 Mission Action Plan

- a) **Schedule of next items to be reviewed.** The Leaders of sections are asked to report back to the next PCC .meeting
- b) **Pastoral Care.** We have more need than we have capacity to provide. Home Communion is being provided by Pam Baker and Ann Turner.
- c) **Eco Church The Bat evening** went well, with a number of families who had not been before. The monitor picked up a number of varieties of bat. Just under £100 was raised.
- c.i) **EV Parking**. Thank were expressed to Richard Bonnie for his work on this and the Quick Win grant for the roof repair.

Two concerns were expressed: the length of contract and the reduction of parking space. A formal decision is yet to be made but the PCC agreed that Richard should be asked to press on and explore the Forward EV proposal but that, before a contract is agreed, the Diocesan Legal Team should be asked to look at it and advise the PCC.

7 Governance

Health and Safety. No incidents had been recorded although a few people had reported being stung by wasps inside the church.
